What is the overall <u>deductible</u>?	\$3,500 individual (single coverage) / \$7,000 family* per calendar year. *An individual on family coverage will not have their <u>deductible</u> exceed \$5,000.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.
Are there services covered before you meet your <u>deductible</u>?	Yes. Certain <u>preventive care</u> and those services listed below as " <u>deductible</u> does not apply." "No charge" means \$0 <u>copayment</u> or 0% <u>coinsurance</u> , regardless of <u>deductible</u> applicability. Does this plan provide Minimum Essential Coverage? Yes
